Collections/Enforcement - Byron Pipkin for Gerald Sherburne

A late fee forgiveness was approved for a new homeowner. (4-0) Discussion was held regarding a request for a second late fee forgiveness. Due to the fact the last request by the homeowner was several years ago and the homeowner stated the statement was sent to the wrong address along with other AVCSD mailings the board approved the request. Old Business

Well #3 - Byron Pipkin

Moving the PG&E lines from the old pole to new pole will take place on Oct. 4 -- that is a hard date set by PG&E. The transition should take about 4 hours and only 1 house will be affected. The well work is expected to start mid October.

PVC Fencing - SP Mann

Discussion was held regarding the placement and the type of fencing to install around the water line and the irrigation system located at the corner of Auburn Valley Road and Viewridge Drive. SP will follow up with estimates of different types of fencing suggested - PVC fencing, boulders, treated posts with cables.

Expenditures

A motion was made to authorize the AVCSD President or Vice President to make expenditures up to a \$1,000. per incident for miscellaneous expenses. The motion was seconded and approved. (3-0 / 2 absentees)

New Business

AVCSD Meetings - Date and Time

A suggestion was made to change the monthly AVCSD meetings to a different time due the current Board of Directors availability. A proposal was made to change the meetings to Wednesdays evenings with a start time of 6:00 p.m. The proposal was tabled until Jerry Sherburne could be consulted as he was absent from this meeting.

Resolution 2023-2 - Overdue Bills Process

Byron presented the Resolution and further explained Attachment A (attached). The full resolution will be posted on the AVCSD website.

Byron made the motion to approve Resolution 2023-02 as edited on September 26, 2023 and to rescind any prior bill collection process approved by previous AVCSD Board of Directors. Resolution 2023-02 will be the only bill collection process done by the AVCSD Board of Directors. The motion was second and approved. (3-0 / 2 absentees)

Adjournment - there being no further business before the board, the meeting was adjourned at 1:45 p.m.

AVCSD charges the following additional fees in addition to the above fees/charges:

\$125.00	Terminating Water Service (shut off)
\$125.00	Reconnecting Water Service
