## BOARD OF DIRECTORS MEETING AND PUBLIC HEARING Saturday, August 14, 2021

Meeting held at John Imrie's Home

Meeting called to order at 9:44 a.m.

Roll Call: Jim Leidigh was absent

## **Reports From Directors:**

## Treasurer's Report - Dale Kuehne

#### Status of accounts as of July 31, 2021

Money Market Account (Restricted for Bonds)	\$264,590.13
Operations and Maintenance	\$400,899.00

All bills are paid current.

#### Receivables as of July 31, 2021

Money and Market Account (Restricted for Bonds)	\$33,221.10

As a community water system, AVCSD may be eligible to receive funding through the COVID relief program. As such, an application has been submitted to the State Water Board. The program is currently in development and the full program requirements and eligibilities have not yet been determined. It may be a long shot, but AVCSD's commercial account declared bankruptcy partly from COVID and the district is unsure if it will be receiving any money at this time from the club. The unknown is if the trust attorney will be paying current bills.

### **Budget Vote:**

At the June AVCSD meeting, the budget for the fiscal year 2021/2022 was presented with an increase in the sewer operation and maintenance from \$115 to \$125 per month and an increase for water operation and maintenance from \$40 to \$45 per month. It was further proposed that the operation and maintenance charges be nominally increased over the next five years. The increase proposed would be the lesser of the consumer price index or 2 percent. The AVCSD Directors voted at the June meeting to pursue the increases.

Pursuant to the government regulations of Proposition 218, the community was given 45 days to file any complaints. During this 45 day time, 5 or so questions were answered to the satisfaction of the community members and no complaints were received. A motion was made and approved to increase the monthly dues for the sewer / maintenance \$10.00 per month and to increase the water operation / maintenance \$5.00 per month and the operation / maintenance charges will be nominally increased over the next five (5) years. (4-0)

## "Old Community" Bond

Dale Kuehne and Jim Leidigh will meet with a US Back official by video conference this next week regarding the "Old Community" Bond. The Bond will be paid in full as of October 1, 2021. The Spyglass Bond is paid in full September 30, 2027.

#### Water Conservation

The AVCSD Board of Directors is asking each resident to conserve water! During this summer's extended heatwave and the drought, the wells are having a very hard time keeping up with the demand. Most of the water used by each residence this time of year is for outdoor irrigation. The community is being asked to water their lawns and plants only three (3) times per week and **no watering on**  **Sunday.** AVCSD's water system operator will be monitoring usage by frequent reading of the meters to get a handle on the problem of compliance.

## **Public Comments**

Discussion was held regarding the two (2) restrooms located on the golf course fairways. Due to the bankruptcy, the issues of locking the restrooms and water leakage / usage in the restrooms will need to be done through the attorneys and bankruptcy trustee.

**Adjournment** - there being no further business before the board, the meeting was adjourned at 10:35 a.m.
